Wildfire Recognition Sunday - For Oregon Synod Assembly April 30 – May 1, 2021

WHEREAS, Roughly 1.07 million acres burned during the 2020 Oregon State wildfire season, the second-most on record, with a firefighting cost of \$354 millionⁱ; and

WHEREAS, over 4,000 families lost their homes across the state following the Historic September 2020 Fires and Labor Day Windstormⁱⁱ, including members of the Oregon Synod; and

WHEREAS, Oregon Gov. Kate Brown, consistent with the reporting of the Oregon Climate Change Research Instituteⁱⁱⁱ, has stated that, "this horrific firestorm of dry weather, hot wind and drought conditions, will not be a one-time event," but "Unfortunately, it is the bellwether of the future."^{iv}; and

WHEREAS, members of Oregon Synod congregations responded generously and graciously to wildfire survivors, even in the midst of the COVID-19 pandemic; and

WHEREAS, the Oregon Synod Disaster Preparedness and Response Team, in conjunction with the Bishop's Office, continues to act lovingly and decisively in the aftermath of this disaster; and

WHEREAS, Lutheran Disaster Response U.S. has worked tirelessly with and through the Oregon Synod Disaster Team and Synod Office, consulting with them, offering professional case manager training for various Oregon Aide Agencies, and funneling \$20,000 in direct aid to benefit survivors; therefore be it

RESOLVED, that the Oregon Synod, gathering in Assembly April 30 – May 1, 2021 under the theme of *"Faithful in the Fray,"* thank Bp. Laurie Larson-Caesar and Oregon Synod Disaster Team Leaders John Core, Charlene Larsen and Jan Wierima for their unwavering leadership this past year; and be it further

RESOLVED, that the Oregon Synod Council write letters of appreciation and thanks to ELCA Lutheran Disaster Response Director John Pyron and Assistant Director Rev. Joseph Chu for their faithful accompaniment of those serving Oregon wildfire survivors this past year; and be it further

RESOLVED, that congregations of the Oregon Synod be encouraged to set aside one Sunday in September of 2021 as "Wildfire Recognition Sunday," (September 7, 2021 being the one-year anniversary of the Labor Day Fires); and be it further

RESOLVED, that the Oregon Synod Disaster Preparedness and Response Team be asked to prepare a litany, prayers and bulletin insert for this Sunday; and be it further

RESOLVED, that members of celebrating congregations be given the opportunity to make donations to Lutheran Disaster Response U.S. in gratitude and our desire to support survivors of other disasters across the country.
